LOCAL LAW 9 OF 2007

A LOCAL LAW PROVIDING FOR THE LEVY OF A USER FEE TO RECOUP FUNDS  
EXPENDED FROM THE GENERAL FUND OF THE TOWN OF NEW BALTIMORE ON  
BEHALF OF NEW BALTIMORE WATER DISTRICT NUMBER 4

Be it enacted by the Town Board of the Town of New Baltimore as follows:

Section 1 - PURPOSE

The purpose of this Local Law is to provide authorization for the levy and collection of a user fee to property owners in New Baltimore Water District Number 4 to repay funds expended from the General Fund of the Town of New Baltimore on behalf of New Baltimore Water District Number 4.

Section 2.

The Town Board of the Town of New Baltimore hereby determines that the amount of \$16,525.79 has been expended from the General Fund of the Town of New Baltimore on behalf of New Baltimore Water District Number 4, said expenditures having been made in relation to the establishment of said Water District, which was duly established by Order of the Town Board of the Town of New Baltimore on May 16, 2005.

Section 3.

The Town Board hereby declares that the amount of \$16,525.79 shall be repaid by the property owners of New Baltimore Water District Number 4, in the same proportion as the benefit formula set forth in the Map, Plan and Report filed in September, 2004 in regard to the establishment of New Baltimore Water District Number 4. A listing of the amount to be levied against each property is set forth in Exhibit A, attached hereto and made a part of this Local Law.

Section 4.

The Town Board hereby authorizes the collection of the amounts set forth in Exhibit A by the issuance of an itemized bill to each property owner listed in Exhibit A, to be collected in conjunction with the New Baltimore Sewer District Sewer Use Fee. Said itemized bill shall be issued on or about January 15, 2008, and shall be due and payable on February 15, 2008.

#### Section 5.

The Town Board hereby authorizes the imposition of a late fee of 1% per month on any unpaid amount of this levy charged to a property owner of New Baltimore Water District Number 4, and further authorizes that any amounts unpaid as of November 15, 2008, along with applicable late fees, shall be assessed and collected as an unpaid charge attributable to the real property.

#### Section 6. – EFFECTIVE DATE

This local law shall take effect immediately upon filing in the Office of the New York Secretary of State.
