The Town of New Baltimore hosted an open House on May 9th to officially open the Sheriff substation at the Town Hall. Joining Sheriff Greg Seeley for the ribbon-cutting ceremony were Sen. Jim Seward, Assemblyman Tim Gordon, County Legislature Chairman Wayne Speenburgh, New Baltimore representative Jim Van Slyke, Supervisor David Louis and members of the New Baltimore Town Board. Also present were members of Boy Scout Troop 45 who helped frame the walls in the station.

Construction on the project began in spring 2008 financed by a \$5,000 grant which Gordon helped secure. The New Baltimore Town Board also provided roughly \$2,000 in funds. Councilman Art Byas oversaw the design and construction of the project with personnel from the Sheriff's Office, CO's,

Town of New Baltimore and many volunteers. Between Gordon's \$5,000 grant, the \$2,000 put up by the town, the volunteer hours, trustee labor and boy scouts participation, the cost to the taxpayers was next to nothing. In addition, Sheriff Seeley pointed out that he did not have to hire additional deputies as the substation keeps the deputies in the rural community where they should be and cuts down on 911 response times.

With the opening of the New Baltimore branch, Sheriff Seeley is confident the entire county has adequate police presence. According to Seeley the opening of the substation in our town is a benefit for both our residents and the officers. The Town gets 24/7 police service and the officers are able to drive their own car to the job at the substation, change into their uniforms and begin their shift

right away instead of reporting to Catskill to pick up a patrol car. There are now four deputies and two patrol cars assigned to New Baltimore. The deputies work 12-hour shifts, either from 7 a.m. to 7 p.m., or vice versa.

Historical Notes

Why Stanton Hill?

I was trying to figure out what to write for this latest newsletter when someone asked about Stanton Hill. How did it get its name when other families seemed to predominate in that area, as evidenced by Powell Hill Road? Plus, there still are Stantons with their big farm in Coeymans. There are deeds describing a location as Stanton Hill in New Baltimore as least as far back as the 1790s.

For some reason, the name Ebenezer Stanton raised a little glimmer in my memory bank and gave me a place to start investigating. A search of the 1790 federal census found that Ebenezer, James, John and Nathan Stanton all were listed consecutively in Watervliet with a Reuben nearby. Around them were people with familiar names in New Baltimore and Coeymans history: Vanderzees, Witbecks, Ten Eycks, Coonleys, Houghtalings, Blaisdells, and Springsteads. Up to 1791, Watervliet came from north of Albany, around that city's western edge, down to include what became the Town of Coeymans. By the 1800 census, all Stantons are living in Coeymans.

I then did an Internet search for the names Ebenezer and Reuben Stanton (more uncommon names usually find more pertinent results). I found that Joseph and Abigail Freeman Stanton of Connecticut had a number of children, including boys named Ebenezer, Reuben, Nathan, Joseph and James. Ebenezer apparently came from Connecticut through Dutchess County and settled near his brother Reuben who was in south Westerlo. At least one genealogy website said that Reuben died at Stanton Hill, Coeymans but another said that at least he, and perhaps Ebenezer, was buried in the Stanton Cemetery at Newry. For the geographically challenged, New

Baltimore, Coeymans, Greenville, and Westerlo all come close together here in the great northwest. Newry is out that way in Greenville.

Ebenezer married Mary Palmer. Their first four children seem to have been born in Dutchess County but the fifth, daughter Hanna, looks to have been born in Coeymans in 1778. So, it looks like the Stantons were among the many people who moved to Greene and Albany Counties around the Revolution. By the way, there are an Ebenezer, Nathan, Joseph, and James Stanton all listed on the roster of Captain Henry Van Bergen's Greene County unit in that war.

By the 1820 federal census, there is a John Stanton in Greenville, Nathan in Cairo, and Joseph and Reuben in Westerlo. According to the online genealogies, Ebenezer died in 1818. I always have questions about these kind of findings. Were all these Johns and Reubens and Nathans the same people or could one Nathan be another Nathan's son or are they unrelated?

I took a look at the cemetery indexes at the Vedder Research Library to see if anyone named Stanton was buried in Greene County. The only possibly interesting name that immediately popped out was at Greenville's Locus Grove Cemetery where someone named Hannah Stanton, wife of John, is interred. There is no listing for John. Hannah died in 1829 at the age of 66. Her maiden name was Garrett. The Garretts were a pioneering family at Stanton Hill. Is there a connection? Sorry to leave you all in a lurch but newsletter deadline time has arrived and I still need to track down a Garrett family genealogy. Hanna, who are you?

2010 Census Activities Underway

The United States Census Bureau has begun their field work in preparation for the 2010 Census. A complete census is conducted every 10 years, and is very important to New York State and to towns like New Baltimore.

The population totals for New York will determine the number of seats that New York will hold in the House of Representatives, and is a primary measure for many different kinds of funding provided for many government programs. These factors alone make it critical that everyone is counted during this census.

The 2010 Census will differ from prior census taking. Instead of a long detailed form, the census form for 2010 will consist of only 10 easy questions, and should take no more than a couple of minutes to complete. All census forms are required by law (Title 13 of the United States Code) to be kept completely confidential. Census Bureau employees that violate this law are subject to a prison term of up to five years and a fine of up to \$250,000. All census workers are also subject to security and employment reference checks.

For the past several months, census workers have been circulating in all areas to catalog an entire list of addresses to ensure that all homes are identified so that they can receive the census forms. The actual census forms will be mailed in February and March, 2010 and are to be returned by April, 2010. Beginning in April 2010, census workers will visit homes that did not return their census forms by mail to complete the census forms in person.

Recruitment of census workers has begun and will continue through the end of May 2010, for temporary

assignments, most lasting 5 to 10 weeks. These jobs will offer competitive wages and flexible schedules, and allow people to work in their areas. To apply for a census job, call the following toll free number: 1-866-861-2010.

Town Board News and Issues

Town Board Report

The Town Board met in regular monthly meetings held on April 13th, May 11th and June 8th, and a work meeting held on April 27th. Here is a summary of the actions taken:

April 13th

- The Board awarded a contract, pursuant to competitive bid, to Eagle Associates for the amount of \$8,700 for 2009 for the mowing of town parks.
- The Board, in response to a petition signed by residents of the portion of Highmount Road between County Route 54 and Reservoir Road, renamed that section of road from Highmount Road to Valley View Drive.
- The Board adopted a Resolution congratulating town resident Rebecca Herrington for her receiving the Girl Scout Gold Award, which is the highest award bestowed by the Girl Scouts.
- The Board adopted revisions to its Town Website Policy
- The Board approved a contract with Apogee Media Services to provide webmaster services for the Town of New Baltimore for the period June 1, 2009-May 31, 2010, at a cost of \$700.

April 27th

- The Board appointed town resident Kirk Trombley as a Parks Laborer, at a salary rate of \$10.70 per hour.
- The Board authorized Supervisor Louis to execute a contract with the Mohawk and Hudson River Humane Society for the sheltering of animals for 2009.

May 11th

- The Board accepted a proposal by Delehanty Construction for the replacement of the roof at

the Town Highway Garage, at a cost of \$9,950.

- The Board authorized the expenditure of \$9,950 for the Highway Garage roof replacement referenced above from the Capital Reserve Fund for Buildings, thereby not increasing the 2009 Town Budget to pay for this expense.
- The Board authorized the advertisement for bids for the sale of used highway equipment no longer needed by the Town Highway Department.

June 8th

- The Board accepted the resignation of Councilman Kevin Kuenster, who tendered his resignation, effective June 8th, since he is moving out of the Town of New Baltimore.
- Following a public bid opening, The Town Board authorized the sale of the following used equipment:
 - 1969 Wapco Motor Grader for the amount of \$1,275.
- The Board approved an increase in the salary of the Assessor's Clerk to reflect the end of the probationary employment period, on the recommendation of the Assessor, from \$10.50 per hour to \$11.00 per hour.
- The Board authorized Janet Brooks, Town Clerk, to attend the Cornell Municipal Clerks Institute 2009 Annual Training Seminar to be held from July 19-23, 2009.
- The Town Superintendent of Highways, Denis Jordan, presented his plan for road resurfacing for 2009.
- The Board authorized, by the adoption of a budget amendment, an increase in the 2009 Highway Budget to allow for more road resurfacing to be accomplished.

The budget increase will be financed by revenues received for storm damage reimbursements from the Federal Emergency Management Agency (\$80,000) and a one time use of \$50,000 from the accumulated surplus in the Town's General Fund.

- The Board authorized the attorney for the Town to notify a property owner that remedial work that the property owner was first cited for in 2005 must be completed no later than August 1, 2009, and that failure to do so shall permit the Town or its agents/contractors to enter upon said property and to demolish and remove the unsafe structure in accordance with the Town Code.

Town Codes Now Available on Internet

The Code of the Town of New Baltimore, which includes all ordinances and local laws adopted by the Town Board, has been revised to incorporate recent changes in local laws adopted in 2008 and 2009, and is now available on the internet.

First published in 1986, the Code of the Town of New Baltimore includes 34 separate chapters. Many of these chapters include ordinances and local laws adopted prior to 1986. This most recent update was compiled by Supervisor David Louis, and reviewed by the Attorney for the Town, David Wukitsch. This effort saved taxpayers over \$10,000, which was the price quoted by a private publisher for performing the same work.

In this update, 4 of the 34 chapters of the Town Code were revised, and the publication format was changed to 8 1/2" x 11" (letter size paper), so that printed copies would fit easily into standard binders.

The Zoning Board of Appeals did not meet in March, April, May or June as there were no applications to come before the Board.

Planning Board Reports

March

April's report to the Town Board outlined the Planning Board's meeting on March 12, 2009, where the following business was transacted:

- Received a Minor Subdivision Application for the four-lot subdivision of property owned by Page, Vitollo, Penu, Perniciaro and Kubica located off of Route 144. Required Public Hearing was tentatively scheduled for April, then postponed to 7:30 p.m. May 14 at request of applicants.
- Discussed with Harry (Butch) Medert, Jr., and daughter, their plans for reestablishing a corner store in building owned by the Mederts at the corner of Routes 26 and 51.

April

At the April 9, 2009, meeting, the Board:

- Continued discussion with the Mederts regarding reestablishment of the corner store at the corner of Routes 26 and 51. Required Special Use Permit. Application and Site Plan Application were submitted and accepted as complete. Required Public Hearing was scheduled for 7:45 p.m., May 14.
- Discussed with Frank Orlando, Jr., and his attorney, George McHugh, Mr. Orlando's plans to go forward with the proposed storage unit facility/modular home sales business brought before the ZBA for Area Variance and Special Use Permit in 1996 as well as before the Planning Board for Site Plan in 1996. There is to be no change in 1996 plans for the property located between 9W and Flatbush Road just north of Taylor Monument.

May

June's report outlined the meeting on May 14, 2009. The Planning Board held public hearings for the Lands of Kubica, Penu, Perniciaro, Vitollo, and Page Minor Subdivision application and the Special Use Permit and site plan application for Harry Medert, Jr. for a proposed country store. In the regular meeting that followed, the Board approved both applications.

The following notice will be distributed by your local fire department during their fundraising activities. You may use the form below to send in for a free reflective house number sign. ACT FAST! The free signs are available through bulk purchase using grant funds. After those resources are exhausted, a fee may be assessed for the cost of manufacturing the sign.

To All Town of New Baltimore Homeowners:

In 2008, the Fire Chiefs in the town's two fire districts expressed their concern that emergency service providers may not be able to find houses when responding to fire and medical emergencies, because reflective house number signs (know as E911 signs) that are visible during the day or night are not posted at the street entrance to every home in the town. In response to these concerns, and instead of making a new town law, the Town Board requested and received funding from Assemblyman Tim Gordon in the newly adopted State Budget to provide house number signs for homes in the Town of New Baltimore. These reflective house number signs are visible during the day or night and will be provided free of charge to any homeowner that does not currently have a visible house number sign at the street entrance to their home. To assist in this effort, the Cornell Hook and Ladder and Medway-Grapeville Fire Companies are volunteering to install these house number signs as a free service to ensure that they are visible to responding emergency services providers. This new program will help emergency responders get to the emergency with much less delay.

We are requesting that if you do not currently have a reflective house number sign that is visible during the day or night, please order one to be installed at your home by doing one of the following:

- (1) Tear off the bottom of this letter, and return it in person or by mail to the New Baltimore Town Hall, 3809 County Route 51, Hannacroix, NY 12087, Attention: Emergency Services; OR
- (2) Contact the Town Hall by telephone at 756-6671, and make your request for a reflective house number sign; you must provide the information that appears at the bottom of the letter.

Thank you in advance for your help in making sure that all homes in New Baltimore can be quickly responded to in the event of an emergency.
