Ag Fest

The 2010 New Baltimore Antique Machinery and Agricultural Festival was once again a great success. Many thanks to the VanEtten family, all the corporate sponsors, the Town, and the Cornell Hook and Ladder Fire Company and Ladies Auxiliary who provided delicious food and support. Without this partnership, the festival would not have celebrated 19 plus years!

The attractions drew approximately 2,000 visitors to the VanEtten Farm on Sawmill Road. Events included the garden tractor and antique tractor pulls, the antique steam tractor, and airplanes taking off and landing. Entertainment under the big tent included Ralph Barger and Peaceful Country, Squeeze Play, Steve's One Man Band, and Kevin Hotaling with karaoke. Free children's activities included Peggy Were with temporary air-brushed tattoos, pie and pudding contests, sand boxes of corn, oats, and colored sand, the bouncy bounce, a dunking booth, sack races, the cake walks, craft-making with beads and Indian corn, sand art and face painting. These fun events were all made possible with help from Ken Burns and family and a grant from Greene County.

Visiting speakers included Dean Davis and his reptile friends and Richele Ford of Blodgett Hill, a wildlife rehabilitator, specializing in birds of prey including hawks and owls.

The most successful event was the Silent Auction lead by Virginia Palmer and was supported by 70 local businesses and community leaders.

A special thank you goes to the Ag Fest Committee for their hard work in planning this annual event and the VanEtten Family who graciously volunteer their farm each year.



HISTORICAL NOTES

History Jottings— The McAuliffes

I recently was researching the World War I period as it happened in New Baltimore. Of the several war memorials in front of the Gill Road firehouse, the most elaborate is a distinguished looking bronze plaque commemorating the 1914-1918 conflict. One particularly interesting thing aroused my curiosity when reading the names on it. There are three McAuliffes listed, Robert, Howard, and Gerald.

I took a look in the Historian's files at Town Hall and found a newspaper clipping about Mrs. Joseph Fletcher of Troy who had sent four sons to serve in the military, three at the time in the Navy. The article goes on to quote at length a letter from Robert describing an attack on his ship by a German submarine. Robert, Gerald, and Howard served in a variety of locations in Europe, facing actual combat on occasion,

After looking at the 1915 New York State census, we can only assume that the boys' mother remarried and moved to Troy from New Baltimore. That census lists Minnie McAuliffe as a 45-year-old housewife with her seven children making a home at the south end of Main Street. Robert was a river pilot while Chester and Howard were a steamboat watchman and quartermaster, respectively. Gerald was just 16. The other three children were 14 or younger, Marcia, Herbert, and Charles.

The November 20, 1917 edition of *The Recorder*, a Catskill weekly

newspaper, published a letter from Howard and Gerald McAuliffe: "I write to thank you for the Christmas packages which you sent my brother and myself. We not only appreciate them because they are useful, but the very fact that you sent them proves to us that we have not been forgotten, and that it is not only the enlisted men who are fighting this war, but it is also the great organizations at home, and I know of no other organization greater than the Red Cross Society. It makes us proud to know that the people of our old home town are interested in this work."

The 1920 Federal census had Joseph and Minnie Fletcher living in Troy in the same household with all the children named above. The 1900 and 1910 Enumerations list Dennis and Minnie McAuliffe in New Baltimore with their growing brood. Dennis was a shoemaker with his own shop.

There is a Dennis McAuliffe buried in Chestnut Lawn Cemetery with a death date of 1914. Nearby are the graves of Minnie C. Smith (1869-1947) and Chester (1892-1939), Gerald (1899-1945), and Herbert (1903-1982) McAuliffe. If this is her, Minnie may have married another time or possibly reverted to her maiden name. According to his tombstone, Gerald died in December after the war.

Thanks to the brave McAuliffe boys and all the other men and women who valiantly represented New Baltimore in our all-too-many wars. *Clesson Bush, Town Historian*

RETURN THE F.A.V.O.R.

Greene County Clerk Mike Flynn and Veterans' Service Agency Director Jack VanLoan have announced the Return the F.A.V.O.R. Veteran Discount Program. In recognition of the service and sacrifices made by our returning veterans, participating Greene County retailers will offer a discount to honorably discharged veterans. Any veteran living in Greene County can receive a card once they have recorded their record of discharge with the County Clerk's office.

To obtain a card, visit the County Clerk's office any weekday between 9 AM and 1 PM. If a copy of Discharge (Form DD-214) has been filed, just present a photo ID (Driver's License). If the discharge has not been recorded or if the veteran is not sure whether it has, bring an original or Certified Copy of the DD-214 to the Clerk's Office and it will be photocopied and recorded. The original will be returned. There is a \$5 fee which only covers the cost of the equipment and staff to produce the cards.

Current discounts range from 10-50 percent and include home and garden, automotive, dining, personal services, health and wellness, and recreation services. New business applications continue to arrive and the list of participating merchants is growing. A current listing can be found at www.greenegov.com.

The County Clerk has also invited any businesses in the Town of New Baltimore to take part in this program and offer a discount to our veterans. Applications are available at Town Hall or through the Clerk's Office at 719-3255.

At our successful Business Breakfast, Barry Henck from Central Hudson announced three rebates for energy efficient cooling equipment.

- Residents can earn a rebate of \$50 for an old, inefficient refrigerator or freezer that is operational and between 10 and 30 feet in size. Central Hudson will have the unit picked up for free and no purchase is necessary. For details or to make an appointment for pickup, go to www.SavingsCentral.com or call (866)706-3995 until December 31.
- A mail-in rebate of \$50 toward the purchase of a new Energy Star window air conditioner (or \$100 toward a through-the-wall unit) can be received by turning in the old units at Sears in the Hudson Valley Mall in Kingston and get a Proof of Recycling certificate. - \$600 rebates are available for residents who install a new, energy efficient central air conditioning system in their home. Helpful Hands

Two Boy Scouts in the Town of New Baltimore recently completed their Eagle Scout projects which included planning, developing, and leading a community service project. Congratulations to Jack Hilscher and Kendall Rebusmen for their dedication, commitment, and leadership in completing two projects that will benefit many families and residents in our community.

Jack Hilscher, son of Nancy and Ted Hilscher, completed his Eagle Scout project which consisted of expanding, and improving the Stanton Hill Cemetery. The Stanton Hill Cemetery Association acquired a new plot of land that needed to be seeded. Jack collected hay from a local barn and used it as mulch to prevent soil erosion and cover for the new seed. After the grass seed and hay was spread, Jack worked on the eastern border, which was overgrown with brush and needed to be cleared so there could be more gravesites for the cemetery. The final piece of his project was the placement of a stone monument welcoming visitors into the cemetery and the planting of flowering shrubs. The monument, pictured at right, has the name of the cemetery and a plaque noting its inclusion on the Greene County Historical Register.



Kendall Rebusmen, son of Paula and Ken Rebusmen, recently completed his Eagle Scout project at the Cecil Hallock Park, District 2. As a Varsity Pitcher at Coxsackie-Athens High School, Kendall used his fondness for baseball when deciding his Eagle Scout Project. He completed approximately 215 hours of labor as well as numerous additional hours for research and design.

Additions to the ball field included first and third baseline fences, cut in baselines and the infield, regrade and fill in around bases, replace all bases with removable bases, adding a rubber belt to the lower back stop, and constructing benches on the first and third base lines for players.

OPEN BURNING REGULATIONS

The New York State Department of Environmental Conservation adopted restrictions on the open burning of residential waste which became effective **October 14, 2009**. The open burning of residential waste is prohibited in all communities statewide, regardless of population, with exceptions for burning tree limbs and branches at limited times and other certain circumstances listed below.

In towns with a total population less than 20,000, tree limbs may be burned with attached leaves. The limbs must be less than 6 inches in diameter and 8 feet in length, but is **not allowed from March 16 through May 14 due to the increased risk of wildfires**. Burning of leaves is **banned** and burning of trash is **prohibited** in New York State.

Effective October 14, 2009, all open burning is prohibited in New York with several exceptions:

- On-site burning of limbs and branches between May 15 and the following March 15 in any town with a total population less than 20,000.
- Barbecue grills, maple sugar arches, and similar outdoor cooking devices.
- Small cooking and campfires.
- On-site burning of organic agricultural wastes but not pesticides, plastics, or other non-organic material.
- Liquid petroleum fueled smudge pots to prevent frost damage to crops.
- Ceremonial or celebratory bonfires.
- Disposal of a flag or religious item.
- Burning on an emergency basis of explosive or other dangerous or contraband by police, etc.
- Prescribed burns performed according to state regulations.
- Fire training with some restrictions on the use of acquired structures.
- Individual open fires to control plant and animal disease outbreaks as approved by DEC upon the request of the Commissioner of Agriculture and Markets.
- Open fires as necessary to control invasive plant and insect species.
