

OPENING REGULAR TOWN BOARD MEETING

Deputy Supervisor Ruso called the meeting to order at 7pm and announced unfortunately Supervisor Dellisanti was called out on emergency. Pledge of Allegiance was said. Also attending: Councilwomen Benway and VanEtten, Councilman Norris, Attorney for the Town Rappleyea, Highway Superintendent Jordan, Town Clerk Brooks and 34 members of the public who signed the attendance sheet.

Absent: Supervisor Dellisanti (family emergency)

APPROVAL OF MINUTES

Regarding the minutes of December 19, 2013 Public Hearing on Local Law 3 of 2013 submitted by the Town Clerk, without quorum from 2013 meeting, they remain unapproved.

Regarding the minutes of **December 19, 2013 Special Meeting** submitted by the Town Clerk, without quorum from 2013 meeting, they remain unapproved.

PUBLIC COMMENT PERIOD

Rodney Krzykowski- awaiting a FOIL request; to clarify, a comment was made concerning a letter to Town Clerk, became a joke, not a joke, the notations on letter mean something, taken from Uniform Commercial Code, law of the land since 1953, said he belonged to conspiracy and called a terrorist, he tries to declare his right to given constitutional rights. He doesn't belong to any groups like OK bombing, in the past have tried to link back to Revolutionary War; he declares his rights as sovereign citizen, guaranteed by the Constitution. He recommends condensed version, read by lawyers and students. As far as connecting dots, he said he was born in 1940 New Baltimore, til 1953, back to New Baltimore in late 60's, pays taxes, still maintain businesses out of town, married, another piece of property; for someone to say he doesn't believe in government is wrong, believes in what it should be and get it back. About 'sovereigns' garnering rights by drafting paperwork and submitting it, is entirely wrong; will show that forms are not made up, gotten from Secretary of State of New York, available to anyone, may be filed on internet, has had some rejected for errors, and redid a couple. He believes in the country we should have; people don't realize where we are and what we are, ask folk exercise due diligence and find out, don't accuse of sinister. He has not received all the information requested on original FOIL request and filed in December; the same day he filed FOILS in Ravena, he received that Friday; and has a couple of questions to ask town clerk. Deputy Supervisor interrupted that she is unavailable to answer questions, he should address the Board.

Mr. Krzykowski remembered mention of debt, looked through some of the minutes, but cannot find this information and does he have to file FOIL for that information.

Councilwoman VanEtten said one report was 3 FOILS; large expense, clarified Deputy Supervisor Ruso. Councilwoman VanEtten remembered two in and three finished.

Mr. Krzykowski would like to get copy of the monthly report.

Deputy Supervisor Ruso reminds that yellow card helps new supervisor, cannot answer those questions at this time.

Deputy Supervisor Ruso would like a discussion about the corrective plan for the State Comptroller's Office in response to audit released November 13; deadline is February 11; Regular Meeting on February 10. He will be lead writer of that corrective plan, plan to meet deadline; Office of State Comptroller is helpful and professional. He will put one together and email draft copies to the Board; plan must be submitted to OSC as a result of a vote of the Board; it is relatively simple, not troublesome, guidelines available, think we can get that done, and enforce it. Deputy Supervisor Ruso, as point of reference, has written 45 or so of these in response to Department of Health and not Comptroller's audits, and just follow process. Councilman Norris said adjustments were made to old policy, but not so much about policy, rather plan of action, getting authorization, and saw some evidence of that tonight. Deputy Supervisor Ruso, as a point of reference and earlier resolution, talked with examiner Denise, talked about things that have come up with salt, how to get this done, concerned about supply, she recommended making blanket resolution based on past history and proceed with knowledge. If you find yourself exceeding the \$46,000, everyone will know the type of winter, not that you should exceed, and recommended doing that with other items, like fuel and crusher run, run resolution at beginning of year, must be done fiscal year, not by winter. Board will be very involved; drafts by middle of next week.
