Greene County EMS

The regular monthly meeting was held on May 16. There were 11 EMS calls in April for a total of 39 for the year and we had 94 calls for all of 2016. As of May 16, 2017, there is a projected year-end balance of \$400,000.

Greene County Ambulance Task Force

The Task Force on a Countywide Ambulance has resumed its work. They have made no report as yet.

County Legislator

May 2017 finds the legislature in full swing on many fronts. Along with our regular committee meetings, I attended our Health Services workshop, and the ambulance task force meeting, and the monthly budget workshop highlighting Highway, Solid Waste, and Economic Development, Tourism and Planning. May is Lyme Disease Awareness month and I would encourage anyone needing information on how to protect yourselves and your property from ticks, and the diseases they carry, to contact Cornell Cooperative Extension of Columbia and Greene Counties. Information is available to help show you how to make your property less inviting to ticks, as well as what to watch for should you find one on you. Very common to our area is the white-footed mouse, the leading transporter of ticks. Two New Baltimore residents were honored at the Legislative meeting this month. Amanda Linger was awarded a Certificate of Accomplishment for her receipt of the NYS Association of Fire Districts Scholarship. Amanda, a senior at RCS, was awarded one of four scholarships in New York State, competing against 156 other applicants in 4 regions. Amanda is a member of the Auxiliary in Fire District No. 1, and has over 600 hours of community service in her varying capacities both in and out of school. Richard "Dick" Brooks was given a Commendation honoring his service to our county as the 2017 Greene County Senior Citizen of the Year. I attended the Senior Citizen Day at the Point in Catskill, along with our State and Federal representatives, to thank our seniors for their involvement in our communities. Saturday, May 20th, was our Honor a Veteran Ceremony in Catskill. This year, we recognized G.L. "Johnny" Lyles from Catskill. Johnny was a Vietnam war veteran, injured during combat, who passed away in 2016. The ceremony to celebrate his service to our country was well attended by his friends and family, many veteran organizations, Boy Scouts, Civil Air Patrol, and elected officials. Saturday, June 24th, 8am to noon, will be the annual Household Hazardous Waste Collection Day. The event gets bigger every year, and will be held at the County Highway Garage on Scott Lane in Athens. Scott Lane is located between Black Horse Farms and Schoharie Turnpike on Rt. 9W. Details are on the website, or residents can call (518) 943-4600. Times will be scheduled by last name as in the past. The Governor has issued a Shared Services Initiative through the 2017 NYS Budget process. This requires all County governments to meet with Towns and Villages to see where tax dollars can potentially be saved. Shaun Groden, our County Administrator, has had the first meeting with the panel in Greene County. This brainstorming session resulted in 18 "ideas" for consolidation to be further investigated. We are also required to hold 3 public hearings to solicit ideas from the public. Those hearings will be held Tuesday, May 30th, 6:30pm in the Legislative Chambers, Tuesday June 6th at 6:30pm, at

the Emergency Services Building in Cairo, and Tuesday June 13th at 6:30pm, at the Windham Centre Building on Rt. 23 in Windham. Notable resolutions passed at the May meeting: 1) Determined a negative declaration for SEQRA for the New Baltimore tower project 2) Awarded fuel oil bids at \$1.7545 per gallon for municipalities to piggyback on 3) Authorized the purchase of two (2) 2017 or newer 19,000 GVW cab and chassis 4) Authorized the purchase of two (2) new dump bodies with snow/ice control including install 5) Awarded bids to purchase highway materials 6) Awarded bids for washed and screened crushed stone 7) Authorized the distribution of Mortgage Tax (\$34,420.03 for New Baltimore) The Veteran Parking signs are finished and will be turned over to the Town Supervisor. The Greene County Highway Department was able to make the signs in-house, and did a great job with them. Within the next week, I will be awarding two Wayne C. Speenburgh Youth Grants. The first will be to help support the R C Sportsman club with their youth fishing derby on June 11th. The second will be to assist the R C Sportsman club with their youth archery program, which has grown to over 70 kids, and has added recurve bows to their repertoire. Both of these programs are well-deserving and are to be commended for their work in getting kids to put the electronics away!

Audit & Control

Deputy Supervisor Ruso: A week-and-a-half ago I attended a Conference put on by the Comptroller's Office, held in Saratoga. There were a number of different sessions; one on improper payments that a lot of Towns get themselves in the middle of; the Five Year Plan that we're going to have to put together before the close of the year. There was a lively discussion and display of fraudulent practices, case studies that have happened elsewhere and there was conversation about Consolidation of Services such as I believe was mentioned in our County Legislator's report. Lastly, not this month, I have it mostly ready, but next month we're going to have a packet for yourselves to review. That's going to be about our unallocated fund balance and our reserves and I need to do that every year in house so you'll get that next month.

Building & Grounds/Recycling

Councilmember Irving: We have a new Recycling person.

Supervisor Dellisanti: How's he working out?

Councilmember Irving: He's working out fine and he'll be compiling a report of materials he received by the end of this month and we'll have it for next month.

Councilmember VanEtten: They weren't releasing any grant funds because of the state's budget so that's what the holdup on the whole thing was.

Ellie Alfeld: Do you have a particular piece of equipment that you are looking to purchase?

Supervisor Dellisanti: Yes, Shelly looked at it a year-and-a-half ago.

Councilmember VanEtten: It's already been done. We had to submit that when we submitted the grant application.

Ellie Alfeld: But nothing has changed on that?

Councilwoman VanEtten: No, we've got to call him and make sure because they did drag their feet and he's got to hold to that price. He said he would so we're hoping.

Planning Board

The Planning Board met on May 11, 2017 with the following business transacted: Public Hearing was held on the minor subdivision application for a three-lot subdivision of property owned by Karl Zacek and Peter Zacek e/s of Route 61 on Bronck Island. Public Hearing was held on the major subdivision application for a 16-lot subdivision of a 260-acre parcel owned by Robert and Gittel Egan under contract to New York Land and Lakes Development, LLC bordered by Route 51, Sodom Road and Old Kings Road. In the Regular Monthly Meeting that followed: Approved Zacek Minor subdivision. After extensive discussion and deliberation, approved the Egan major subdivision. Passed resolution renewing the Special Use Permit for J. B. Car Services, Inc. for the period July 1, 2017, through June 30, 2018. Discussed with Frank Orlando, Jr., their current plans to move forward in part with a project approved in 1996 for the placement of self-storage units on property owned between Flatbush Road and Route 9W.

Chair Rob VanEtten: On behalf of the Planning Board, I'd like to ask the Town Board to consider sending a letter to Central Hudson, State Tel. At the Public Hearing we had numerous comments in the area of where this 16-lot subdivision will go which is out along Sodom Road and Kings Road. They're saying they have low power.

Councilmember VanEtten: MH Cable or State Tel?

Chair Rob VanEtten: Well, they have low power or very poor internet. And one of their concerns was that by putting in more homes, it will worsen the situation. But 1) I would like Central Hudson to be aware that there's potential down the road that we will have 16 more homes there.

Supervisor Dellisanti: And State Tel as well or is it MH Cable up there?

Councilmember Briody: Well, it's probably both.

Chair Rob VanEtten: I'm not sure about that.

Deputy Supervisor Ruso: I don't think MH Cable goes up there.

Ann Marie Vadney: I don't think so either because I can only get State for internet where I live and that's through Direct.

Chair Rob VanEtten: But whoever is responsible if the Town Board can send a letter 1) alerting them to the fact there is a subdivision approved.
