GUIDELINES FOR PUBLIC CONDUCT DURING TOWN BOARD MEETINGS

1. The Supervisor shall preside at the meetings of the Town Board. In the absence of the Supervisor, the Deputy Supervisor shall be the acting Supervisor. In the event both the Supervisor and the Deputy Supervisor are absent, the other members shall designate one of their members to act as temporary chairman. A majority of the Board shall constitute a quorum for the transaction of business, but a lesser number may adjourn.
2. Town residents who wish to speak shall fill out a card at the entrances of the meeting room listing their name, contact information, and the subject matter in which they would like to speak. These cards will be collected prior to the beginning of the Town Board meeting and given to the Town Supervisor or Deputy Supervisor in the absence of the Supervisor.
3. Speakers must be recognized by the presiding officer and then proceed to the lectern and state their name and address. They must limit their remarks on official town business to up to three minutes on a given topic and may not yield any remaining time to another speaker. They must address their remarks to the Board as a body and not to any member thereof and not to other members of the audience in the form of a debate.
4. Speakers should present their remarks in a courteous manner and may not make disparaging remarks or personal comments about public officials, town residents, or others. All speakers will observe the commonly accepted rules of courtesy, decorum, dignity, and good taste with no cursing, swearing, clapping, booing, finger pointing, bullying, whispering, or talking that disrupts the proceedings of the business of the Town Board.
5. Any speaker who disregards the directives of the presiding officer in enforcing the rules, disturbs the peace at a meeting, makes impertinent or slanderous remarks, or generally conducts themselves in an inappropriate manner shall be barred from further participation and will forfeit any balance of time remaining for their comments.
6. After a final warning, if a speaker willfully refuses to step down, the Town Supervisor shall contact the appropriate authorities to remove the speaker from the meeting room and to restore order.
7. The Town Supervisor, or in their absence the Deputy Supervisor, shall ensure compliance with these rules.

This policy will be amended by Majority vote of the Town Board.

OPENING OF REGULAR MEETING

Supervisor Ruso opened the meeting at 7:01 PM and the Pledge of Allegiance was said. Also attending Councilmembers Briody, Irving, and VanEtten, Deputy Supervisor Dellisanti, County Legislator Linger, Town Clerk Finke, Highway Superintendent VanWormer, and 4 members of the public who signed the attendance book. Absent: Tax Collector Jordan

Supervisor Ruso: Thank you. I do see that we have Mr. Flores from Delaware Engineering to give us an update on the Wastewater Treatment Plant. I'm ready if you are, sir.

Robert Flores: So you guys have to remember the saga of this because it seems like that way right? We're gonna get close. We opened bids in the beginning of December of last year and then we went through getting the contract signed, equipment ordered, people onsite, excavation, pouring concrete. So we're well into it now. I believe some of the Board members have been onsite maybe about a month or so ago or six weeks ago. It's kind of hard to tell when everything's all torn up and everything's all over the place exactly where it is. We're way beyond the 50 percent mark and we've cleared some significant hurdles. As you know the clarifiers that we're excavating, the bottom of those tanks are below the elevation of the River, water in the River. So even though they're small tanks, it's a difficult excavation. So the fact that we're pouring concrete and we're moving up is a real big step in the project. All the major equipment is on site and it's been delivered. So we're really on the downhill slope of the project now. I still believe the project is going to go into all of December and they'll be some items still left in January and February. So that's basically where we are. Anybody have any questions I can fill in?

Councilmember Irving: You haven't any logistics problems as far as the road going down in and out?

Robert Flores: The road's holding up. We've had lots of concrete trucks and dump trucks, both go in and out of the site. So far so good.

Highway Superintendent VanWormer: Is there room down in there for a plow truck if it should snow before...?

Robert Flores: There's as much room as there always has been.

Highway Superintendent VanWormer: We want to keep as open as we possibly can for you. I'll have to take a ride down and look at it.

Robert Flores: You can still get to the gate, open the gate fully and drive in. There's just more stuff once you drive in.

Councilmember Irving: Well, I'll say I drove my motor scooter down and I had plenty of room.

Robert Flores: That's a good size to be down there with.

Supervisor Ruso: I don't have any question. I did go down on a Saturday myself and took a look around three weeks ago and it just looks like a mess, stuff everywhere. Anybody else have any questions?

Councilmember VanEtten: I don't have any questions.

Supervisor Ruso: What's the completion date estimated?

Robert Flores: I forget the exact dates per contract, but we're roughly in the end of February timeframe.

Supervisor Ruso: I thought it was March going by recollection.

The inventory was produced by the Greene Land Trust with technical support from Cornell Cooperative Extension of Columbia and Greene Counties and Hudsonia Ltd., with funding from the NYS Environmental Protection Fund through a grant to the Greene Land Trust from the Hudson River Estuary Program of the NYS Department of Environmental Conservation. Supervisor Ruso: I'm going to see if I can free up some time on Saturday myself. I'm hopeful myself. We'll coordinate.

County Legislator Pat Linger

October has been a very busy month for our Legislature. I'd like to first mention that the Budget Officer has presented the Tentative 2020 budget to the Board. The public hearing for this budget will be held on November 4th, 6pm at the Catskill High School Auditorium. Once again, spending in this budget is under the State mandated tax cap. The equation would have supported a 2.95% increase but this budget has an actual levy increase of 1.7%. In fact, 8 towns will see a slight reduction in their County tax rate for the second year in a row. These towns either have assessed valuations at or above 100%, or saw large increases in their assessments this year. New Baltimore taxpayers will see a 2.5% increase as our equalization rate is set by NYS at 69 percent. The total budget, which is subject to change by resolution, is \$121,665,757 as compared to the existing budget of \$119,088,760. The increased spending includes the full debt service for the County Jail bond, increased personnel costs associated with State mandates such as Raise the Age, Bail Reform, and Evidentiary Discovery, labor contracts, and increased percentage responsibilities on programs such as foster care. The budget maintains the accelerated debt repayment on CGCC Capital Improvements, saving considerable funds in the future. We will maintain all fund balance contributions, fleet maintenance and turnover, and facility capital improvements. We have also increased the sales tax contribution to the budget by \$1 million. Our health care costs have been held in check, pension costs have risen slightly, and inmate boarding fees have been reduced. We renewed our Shared Services Response Team agreement with Columbia County Sheriff and Hudson Police Department. This relationship has proven very beneficial in our efforts to combat the opioid epidemic and managing high-risk incidents. We heard an update from Cornell Cooperative Extension on the Taste NY store and toured that facility. We were also able to confirm that County tax dollars are not being used to sustain the operation on the NYS Thruway. We passed a resolution in support of an Assembly bill relating to the short term rental of private dwellings. This is in direct relation to the collection of sales tax on rentals through Air Bnb, HomeAway, VRBO, and other online rental platforms. During the summer of 2019, AirBnb released figures showing 43,500 guest arrivals in Greene County, \$7.6 million in host income, and over \$300,000 in uncaptured sales tax. That's just THIS summer, and only AirBnb. Since all of our other resorts, bed and breakfasts, and hotels must pay sales tax by law, we believe the playing field should be leveled. We authorized a contract with the Teamsters Local 294, our Solid Waste employees union, and accepted in full a fact finding report regarding the AFSCME Local 968, highway employees union. This union has gone without a contract since 2014. We reappointed Shaun Groden to a 3-year term as County Administrator, and Bob VanValkenburg as Highway Superintendent to a 4-year term. Emergency Services took a massive leap forward with the final switch to our new communications system this month. The multi-year, multi-million dollar project has upgraded all towers, radio equipment, shelters, generators, computer aided dispatch software, dispatch consoles, and radio frequencies. All 27 fire, 14 EMS, and 9 police agencies operating within the County are now on this new system. All agencies are now able to use on-scene frequencies to keep radio traffic off the main dispatch line, and dispatchers are able to send their signal off all towers simultaneously, reducing repetitive chatter. The streamlining of the communications system will save precious seconds, with increased radio coverage. In addition to all of our regular legislative meetings, I attended a meeting with the mountaintop supervisors regarding improved EMS coverage for the Greene EMS paramedic system. This may well add to our budget by resolution next month at a total annual cost of \$404,000. We have a commitment from Greene EMS of \$93,000, and a grant from Assemblyman Chris Tague for \$50,000 to help defray the cost of a 5th medic fly car. I would like to see a portion of the newly enacted Internet Sales Tax earmarked to pay for this service improvement. If I'm successful, that will limit the impact to the Town tax levy against their share by allowing the County to fund the entire cost of the 5th car. I also attended a farm tour that Assemblyman Tague arranged in Schoharie and Greene Counties. His tour was to show other State Legislators, 15 in attendance, how the new farm bill has affected our local family farms. We toured Story Farms in Catskill, ate a farm-to-table lunch at Gracie's in Leeds, and toured the Field Goods operation in Athens. There were many realities imposed on some folks who never realized what it took for local farms to survive, and the damage done with the swipe of a pen.

The hope is to fix some of a flawed law in the upcoming Legislative Session. I also attended the annual RSVP luncheon to honor our senior volunteers, and served as emcee for that event. We celebrated the over 18,000 hours given by the volunteers, marked several milestones, and Legislators Bloomer, Handel, and myself presented them with a \$1,000 Wayne C. Speenburgh grant toward the Thanksgiving Dinner to be held at the Athens senior facility in November. There's probably a lot that I missed, but if anybody has any questions, I can try to answer them.

Supervisor Ruso: I have two, first off I'm not familiar with Raise the Age Act?

County Legislator Linger: Last year 16 years olds were taken out of the criminal justice system and put into the Family Courts. This year on October 1 that now includes the 17 year olds. We can't house them in a normal regular jail facility. In Greene County we're going to be sending I believe our males to Westchester County, our females to Albany County and it's a very small percentage -- less than 10 a year on a regular basis.

Supervisor Ruso: And the \$50,000 from Assemblyman Tague is for the purchase of the car itself not for operating costs for equipment?

County Legislator Linger: It's a State Aid to Municipalities Grant so we can use it how we need to use it. We pay before the fifth car, the County pays about \$1.2 million for the fly cars for Greene EMS. This is gonna add \$400,000. So within that \$400,000 we can use that \$50,000 grant. So it will defray some of that cost. We expect the first year, if we can get it to a full year and don't have to wait to April for it to begin, just under \$300,000 that we'll have to come up with. We have the new internet sales this year that took effect in June. We don't have any history on that because it's brand new, but we also don't have any history of using that. So it's a good chunk of money that we think we'll have coming that we're not used to spending to put that specifically toward this and take a little bit less of the responsibilities off the Towns.

Supervisor Ruso: I'll just make one comment. I had the opportunity to talk to a Town Board member from Hunter and he said there are about 300 Airbnb's in Hunter alone that are not registered, not gone through the permitting process whatsoever with their Planning Board and so they're almost kind of unknown to all parties including perhaps even the County.

County Legislator Linger: There's over 1,200 of them in the County.

Councilmember VanEtten: And there's nothing really in the zoning, an Airbnb, because it's not like an inn, if you were renting a house.

Supervisor Ruso: But there is something regarding lodging though.

Councilmember VanEtten: Right, there is lodging, but we don't have that specifically and I think we should look into adding that specifically.

County Legislator Linger: There are a lot of Towns that are doing that right now especially the Mountaintop and what they're gonna do is they're gonna require them. Basically it's gonna be the same requirements as what a hotel or motel has to do as far as fire prevention, fire escape plans, emergency information by the door.

Supervisor Ruso: Parking, noise.

County Legislator Linger: Parking, inspections, and they'll have an annual fee that they'll have to pay to cover the cost of those inspections. I know a lot of mountain towns are looking at that right now because they're very active with it. We see it as competition to our resorts that are there and they can charge a lower price because the customers there are not paying the sales tax they're required to pay at the other facilities already.

Supervisor Ruso: Well, there's by my estimate, perhaps a half dozen, maybe as many as ten in New Baltimore.

County Legislator Linger: You're low. There's more than that. But we don't even know if it's gonna go anywhere. There's an Assembly bill, there's not a Senate sponsor yet, but we're gonna support the Assembly bill.

Ellie Alfeld: The question I guess I have is this going to be considered a County tax or are you going to have some come back to the Town?

County Legislator Linger: The sales tax all comes to the State the State sends their half to the County.

Ellie Alfeld: Is there what they call a sales tax and a hotel tax?

County Legislator Linger: We do not have a hotel tax, that's another kind of bone of contention amongst the Board right now. It's called a Hotel Occupancy Tax. That also would have to come from our Board, a request to the State Legislature, would have to be passed by the State Legislature in order for us to collect that. Right now we're discussing that, but there's no movement on that whatsoever. But the sales tax issue would be statewide.

Town Clerk Finke: The Hotel Tax would be renewable, too.

County Legislator Linger: Yeah, it's two or three years I think that you have to renew on a hot tax.

Kristin O'Neill, Assistant Director of the Committee on Open Government, discussed FOIL and the Open Meetings Law. It was very well-attended and I always look forward to these events. 3. On September 26 the Association of Towns sponsored a Planning and Zoning Board School and topics included What Planning Boards Need to Know About Housing and Real Estate, Ethical Consideration on Planning and Zoning Decision-Making, Site Plan Review, and Case Law Update. This was also very well-attended and I met several board members from the North Country

WHEREAS the healthcare costs are more stable with that Gold-level plan with low deductibles, low co-pays and a much lower HRA potential cost;

WHEREAS the contract with MVP Liberty HDHP Gold 2 will be offered to full time town employees effective December 1, 2019 with a monthly premium based on current usage of \$14,272.19.

Supervisor Ruso: That's a bit of an increase since last year, over \$1,000 a month and that's because there's more people we're covering.

WHEREAS the contract with MVP Liberty HDHP Gold 2 will be offered to retirees and/or their spouses who are below age 65 without the associated HRA with a monthly premium of \$632.95 per person;

WHEREAS the Match-back option for the Medicare Advantage plan for retirees age 65 and above will be CDPHP PPO at a rate of \$326.10 effective January 1, 2019 for a total estimated monthly cost of \$3,227.80;

WHEREAS the Met Life dental is renewed as a monthly premium of \$657.73 for a total estimated ~~monthly~~ **annual** cost of \$7,892.76 based on current enrollment;

WHEREAS Empire Vision is renewed as of December 1, 2019 at a monthly premium of \$13.60/\$19.38 at an estimated monthly charge of \$152.32 based on current enrollment;

THEREFORE, BE IT RESOLVED that the Town Board authorizes the Supervisor to sign the agreements for insurance coverages for eligible Town employees and retirees.
