GUIDELINES FOR PUBLIC CONDUCT DURING TOWN BOARD MEETINGS

- 1. The Supervisor shall preside at the meetings of the Town Board. In the absence of the Supervisor, the Deputy Supervisor shall be the acting Supervisor. In the event both the Supervisor and the Deputy Supervisor are absent, the other members shall designate one of their members to act as temporary chairman. A majority of the Board shall constitute a quorum for the transaction of business, but a lesser number may adjourn.
- 2. Town residents who wish to speak shall fill out a card at the entrances of the meeting room listing their name, contact information, and the subject matter in which they would like to speak. These cards will be collected prior to the beginning of the Town Board meeting and given to the Town Supervisor or Deputy Supervisor in the absence of the Supervisor.
- 3. Speakers must be recognized by the presiding officer and then proceed to the lectern and state their name and address. They must limit their remarks on official town business to up to three minutes on a given topic and may not yield any remaining time to another speaker. They must address their remarks to the Board as a body and not to any member thereof and not to other members of the audience in the form of a debate.

- 4. Speakers should present their remarks in a courteous manner and may not make disparaging remarks or personal comments about public officials, town residents, or others. All speakers will observe the commonly accepted rules of courtesy, decorum, dignity, and good taste with no cursing, swearing, clapping, booing, finger pointing, bullying, whispering, or talking that disrupts the proceedings of the business of the Town Board.
- 5. Any speaker who disregards the directives of the presiding officer in enforcing the rules, disturbs the peace at a meeting, makes impertinent or slanderous remarks, or generally conducts themselves in an inappropriate manner shall be barred from further participation and will forfeit any balance of time remaining for their comments.
- 6. After a final warning, if a speaker willfully refuses to step down, the Town Supervisor shall contact the appropriate authorities to remove the speaker from the meeting room and to restore order.
- **7.** The Town Supervisor, or in their absence the Deputy Supervisor, shall ensure compliance with these rules.

This policy will be amended by Majority vote of the Town Board.

Ellie Alfeld: I'm a little confused and I'd like to know if the Board has any decision. The energy farms, solar farms that are coming into the Town in numerous avenues, how are they rated as far as our zoning is concerned? Are they?

Supervisor Ruso: The Planning Board's reviewing all that stuff as it relates to the zoning. All of them so far has not come before us, but I have a recollection that they are within the zoning.

Ellie Alfeld: As what? I mean from what I can gather looking at their plans, it looks like it's all gonna be in residential agricultural areas.

Supervisor Ruso: Certainly not the two on 9W, that's more commercial.

Ellie Alfeld: Well, I don't know how far back the one on the Courts' property is. Is it close to 9W?

Councilmember VanEtten: It is I'm not sure.

Supervisor Ruso: It won't be viewable from 9W with the berms, but the one of the east side with the hillside you won't see it either.

Ellie Alfeld: I realize that.

Supervisor Ruso: I think that is being reviewed with consideration of all the zoning rules at the Planning Board meeting.

Ellie Alfeld: Right well we know that 9W corridor is commercial. So are they commercial and do they fit in that pattern or are they in an ag district or in a residential? I mean it just seems to me we should have some ID of the thing that's it.

James Eckl: I said on the card that my remarks were directed toward Nexamp, but I'll hope you'll allow me to digress a little bit by way of an introduction, though. As I understand the

Community Choice Aggregation or CCA deal requires that the local government pass a local law whereupon it can then act essentially on behalf of the residents to work out a deal and this Board did that on July 25, 2016. The law is in place, the deal is in place, and the reason I mention my interest in the necessity for a local law is that I am wondering if the Community Distributed Generation or CDG deal that the representative of Nexamp discussed at the December 23 meeting, I'm wondering if that also requires the enactment of a local law by this body.

Supervisor Ruso: I don't see where it needs to be, however, that was merely a presentation. We don't have a resolution before us to accept their proposal just so you know and I dare say we probably won't for quite some time. That was their presentation to us as opposed to a program that will be put into place. That'll be decided by us, but that's to be determined.

James Eckl: That leads to my second question, sir, if I may is that if a CDG deal is a deal between the consumer and the supplier directly does this body have a role at all and if so why is the presentation being made? I sat here and watched it on December 23 and I'm wondering why a presentation was indicated to be made to this Board if this Board doesn't have a role to play.

Supervisor Ruso: Only because it was related to the GoodEnergy people and it would be administered by the same folks with this Nexamp people involved. At least the perspective, I didn't get the preference of the Board, but based upon my observations of the presentation I'm doubtful that it will be coming to the Board as a resolution.

James Eckl: I would not ask you to prejudge it, sir, not at all. That wasn't my plan.

Supervisor Ruso: No, based upon what I know. I'm not prejudging it. Based upon what I know already. The presentation did not overwhelm me.

James Eckl: Can we be confident that if this matter progresses any that it will be well-publicized to the community?

Supervisor Ruso: It will be publicized in the same fashion as we currently publicize it. Thank you very much.

BE IT RESOLVED, that the Town Board of the Town of New Baltimore will hold a Public Hearing on January 27, 2020 at 6:45 PM at the Town Hall, 3809 County Route 51, Hannacroix, New York to hear those members of the public who wish to be heard regarding proposed Local Law 1 of 2020, a Local Law to establish a new schedule of real property tax exemptions for persons sixty-five (65) years of age or over and persons with disabilities and limited incomes.

PROPOSED LOCAL LAW #1 OF 2020

A LOCAL LAW TO ESTABLISH A NEW SCHEDULE OF REAL PROPERTY TAX EXEMPTIONS FOR PERSONS SIXTY-FIVE (65) YEARS OF AGE OR OVER AND PESONS WITH DISABILITIES AND LIMITED INCOMES

BE IT ENACTED by the Town Board of the Town of New Baltimore, as follows:

SECTION 1. This Local Law is adopted pursuant to the authority of Real Property Tax §459© and §467. All definitions, terms and conditions of such statute shall apply to this Local Law and are incorporated herein.

SECTION 2. Local Law #1 of 2019 is HEREBY REPEALED.

SECTION 3. The Town Board of the Town of New Baltimore does hereby establish the following sliding scale of property tax exemptions for real property owned by persons sixty-five (65) years of age or over and for real property owned by a person with a disability whose income is limited by such disability, and used as the legal residence of such person, based on the income limits set forth below:

Maximum Income Limit	Property Tax Exemption
\$29,000.00	50%
\$29,000.01-\$29,999.99	45%
\$30,000.00-\$30,999.99	40%
\$31,000.00-\$31,999.99	35%
\$32,000.00-\$32,899.99	30%
\$32,900.00-\$33,799.99	25%
\$33,800.00-\$34,699.99	20%
\$34,700.00-\$35,599.99	15%
\$35,600.00-\$36,499.99	10%
\$36,500.00-\$37,399.99	5%

SECTION 4. Any person who qualifies for a property tax exemption as a person with a disability shall not be eligible for a property tax exemption as a person who is sixty-five (65) years of age or over.

SECTION 5. The maximum income limit set forth in Section 3 above shall be offset by medical and prescription drug expenses actually paid which are not reimbursed or paid for by insurance.

SECTION 6. This Local Law shall take effect immediately upon its filing in the Office of the Secretary of State.

WHEREAS the Town of New Baltimore Planning Board and the Attorney for the Planning Board have reviewed two proposals from engineering firms;

BE IT RESOLVED that the Town Board authorizes the Planning Board of the Town of New Baltimore to contract with Crawford & Associates Engineering, PC for said solar projects.

Councilmember Boehlke: Are we limited to one. I thought we were looking at three possibilities?

Councilmember VanEtten: They were.

Supervisor Ruso: We actually had, this is the fifth possibility, and we end up with two out of the five and for a number of reasons, well for costs and of the like, this one was the chosen one by the Planning Board. So there were five in total, then there were three, then there were two, and now we have to make our choice. You don't want more than one engineering firm per project.

Aline Galgay, Esq.: Only two expressed interest. We solicited five, but only two came back.

Councilmember Boehlke: Well, okay. I figured we might want to keep like two on retainer in the event that one cannot respond.

Aline Galgay, Esq: So for the two applications that are before the Planning Board now, it would be good since these are the first two projects for the engineer to be able to work with the Planning Board on both of those projects and one of them is going to require joint review by the Zoning Board because there are five pieces of property and five sets of variances.

Councilmember Boehlke: I mean you know what I'm saying.

Aline Galgay, Esq.: Yes, I do and I think based on the proposals that were submitted for these two projects, it was in the best interest of the Planning Board to use Crawford. For the next project we can continue to solicit other engineers. But they went to everybody that's on our Town-approved list as well as all the engineers that I knew that worked on solar projects and literally there were only two responses.

Supervisor Ruso: Actually there were more than five if I recall.

Aline Galgay, Esq.: There's the three for the Town and then I think Marjorie sent out letters to another five. There was a lot and those were the only two and the Planning Board discussed the fiscal responsibility because it's the applicant that pays for it.

Rob VanEtten: I just wanted to know how we're going to proceed on this. Does the Town Board, because we have to get the money from the applicant naturally, the escrow. So is the Town Board going to reach out to the applicant or does the Planning Board reach out? Inevitably you have to handle the monies.

Supervisor Ruso: Right.

Rob VanEtten: So are you going to reach out?

Supervisor Ruso: You and I will coordinate that, we'll talk.

Aline Galgay, Esq.: Plus you'll need to sign a contract, they'll probably be a contract, so you'll sign the contract and that money...

Eilleen Vosburgh: Okay, anyhow, so have you heard anything about what they've decided?

Supervisor Ruso: No, they kind of intimated it would be a little while, but at least they were listening. That's how I felt.

Eilleen Vosburgh: I agree. I agree. I think they were listening.

Supervisor Ruso: This is by the way for anyone who doesn't know the bridge replacement on Route 144 near the creek.

Ellie Alfeld: It was in the *Times-Union*.

Eilleen Vosburgh: And they said public comment until this Wednesday. I was, and maybe Alan can make a comment, I was surprised that when they asked emergency services and the fire department that it was only a one minute difference from them going through the hamlet or through Ravena on 9W.

Highway Superintendent VanWormer: If they come down 9W and go New Baltimore Road into the hamlet, it's just about the same distance.

Eilleen Vosburgh: It really is. Okay, I was surprised to hear that. The other question I have is about the sewer rates and it was \$26.something and \$35.9. That must be multiplied by 10 each of those rates wouldn't it be?

Supervisor Ruso: By how many points are related to the particular property. It's a point score. It did say when I read it per point, but it wasn't in writing.

Eilleen Vosburgh: Alright, thank you.
