# **GUIDELINES FOR PUBLIC CONDUCT DURING TOWN BOARD MEETINGS**

- 1. The Supervisor shall preside at the meetings of the Town Board. In the absence of the Supervisor, the Deputy Supervisor shall be the acting Supervisor. In the event both the Supervisor and the Deputy Supervisor are absent, the other members shall designate one of their members to act as temporary chairman. A majority of the Board shall constitute a quorum for the transaction of business, but a lesser number may adjourn.
- 2. Town residents who wish to speak shall fill out a card at the entrances of the meeting room listing their name, contact information, and the subject matter in which they would like to speak. These cards will be collected prior to the beginning of the Town Board meeting and given to the Town Supervisor or Deputy Supervisor in the absence of the Supervisor.
- 3. Speakers must be recognized by the presiding officer and then proceed to the lectern and state their name and address. They must limit their remarks on official town business to up to three minutes on a given topic and may not yield any remaining time to another speaker. They must address their remarks to the Board as a body and not to any member thereof and not to other members of the audience in the form of a debate.
- 4. Speakers should present their remarks in a courteous manner and may not make disparaging remarks or personal comments about public officials, town residents, or others. All speakers will observe the commonly accepted rules of courtesy, decorum, dignity, and good taste with no cursing, swearing, clapping, booing, finger pointing, bullying, whispering, or talking that disrupts the proceedings of the business of the Town Board.
- 5. Any speaker who disregards the directives of the presiding officer in enforcing the rules, disturbs the peace at a meeting, makes impertinent or slanderous remarks, or generally conducts themselves in an inappropriate manner shall be barred from further participation and will forfeit any balance of time remaining for their comments.
- 6. After a final warning, if a speaker willfully refuses to step down, the Town Supervisor shall contact the appropriate authorities to remove the speaker from the meeting room and to restore order.
- 7. The Town Supervisor, or in their absence the Deputy Supervisor, shall ensure compliance with these rules.

This policy will be amended by Majority vote of the Town Board.

Supervisor Ruso opened the Public Hearing by reading Proposed Local Law 1 of 2023. Also attending Councilmembers Boehlke, Downes, and Irving; Deputy Supervisor Dellisanti; Town Attorney George McHugh; Town Clerk Finke; Assessor Dawn DeRose; Highway Superintendent VanWormer; and 4 members of the public who signed the attendance book. Absent: Councilmember VanEtten

**Supervisor Ruso**: That's what we have for today. Dawn, I would welcome you to step up and you describe it better than we do.

**Assessor DeRose**: For the Senior Exemption you would use the 2021 income tax return, last year's. A lot of people don't get it done by March 1<sup>st</sup> so that's why the State allows us to go one year behind. You have to be 65 and it's full income. So for the Seniors it's full Social Security, full pension. We do take some of your IRA. So everything that's added together for the sliding scale, it's not just the set amount for the Advanced.

Ellie Alfeld: What do you mean by you take part of your IRA?

**Assessor DeRose**: So when you get your letter in December on how much you paid, we only take a percentage of it. So just the taxes that you paid. We don't take the full amount that you took out and then we add that all together and see where you stand for the Senior.

**Ellie Alfeld**: My question is how are we to determine, know I know it's gonna be the bottom line on the income tax, your total income?

Assessor DeRose: That's for the enhanced STAR, yes.

**Ellie Alfeld**: When it comes to the medical expenses, copays, and what have you we have to present that proof to you and how we gonna go about that because I can image all the seniors in the Town have got copays and other medical expenses they need to have deducted off of their total income?

**Assessor DeRose**: So normally the insurance company will print out a page of what you paid out and we can use that or just save your receipts throughout the year.

Ellie Alfeld: Okay and would cancelled checks be acceptable?

Assessor DeRose: Yes.

Ellie Alfeld: What about pharmaceuticals? Those are all medical expenses.

Assessor DeRose: So bring everything in. Usually your pharmacy can print out what you paid out of pocket.

Ellie Alfeld: And are we gonna need an appointment to see you to make these copies?

Assessor DeRose: No, you can just come on in.

Ellie Alfeld: With the receipts?

Assessor DeRose: Yes, and then I'll make all the copies for you.

Ellie Alfeld: And give us back the originals?

Assessor DeRose: Yes.

**Supervisor Ruso**: I think it would be wise to call ahead anyhow in case she's in the middle with someone else.

**Eilleen Vosburgh**: Combined okay. The other question is on the law right here it says 'tax exemptions for people sixty-five (65) ... age or over and for real property owned by a person with a disability.' Shouldn't that be an or?

Assessor DeRose: We can change it to or if you want to instead of and.

Supervisor Ruso: You can't have it both.

**Assessor DeRose**: Well, yeah, that's what it is so if you are a senior and you're on the sliding scale and you're disabled too you can only get one. It's the same sliding scale.

**Eilleen Vosburgh**: But at the same time this to me kind of reads that you know you have to have an age limit and you have to have a disability.

Assessor DeRose: Okay, so can we change that to or?

**Supervisor Ruso**: This is not the resolution that we will, we will read the resolution later. This is the Public Hearing to hear...

Eilleen Vosburgh: So it is combined.

Assessor DeRose: Yes, it's combined.

**Ellie Alfeld**: Are we gonna have a sheet with the printout as he just announced starting at \$34,000...

Town Clerk Finke: It's back there.

Ellie Alfeld: Well, I didn't see it because I came in that door.

Town Clerk Finke: They're on both.

Assessor DeRose: Any questions on it?

A copy of the proposed local law is enclosed. A public hearing will be held on the proposed local law on January 12, 2022 at 6:00p.m., at the Town Hall, 18 Russell Avenue, Coeymans, New York.

**Supervisor Ruso**: So if anyone has any interest in seeing their amendment to their local law, you're so noticed.

One is for a Truck Terminal which is in our Code but not defined. So because of the zoning changes it will affect the entire Town of Coeymans. We have to let all of the municipalities that surround us; we have to give them notice. So that's what it is, it's two definitions.

# LOCAL LAW #1 OF 2023

### A LOCAL LAW TO ESTABLISH A NEW SCHEDULE OF REAL PROPERTY TAX EXEMPTIONS FOR PERSONS SIXTY-FIVE (65) YEARS OF AGE OR OVER AND PESONS WITH DISABILITIES AND LIMITED INCOMES

**BE IT ENACTED** by the Town Board of the Town of New Baltimore, as follows:

SECTION 1. This Local Law is adopted pursuant to the authority of Real Property Tax §459© and §467. All definitions, terms and conditions of such statute shall apply to this Local Law and are incorporated herein.

SECTION 2. Local Law #1 of 2020 is HEREBY REPEALED.

SECTION 3. The Town Board of the Town of New Baltimore does hereby establish the following sliding scale of property tax exemptions for real property owned by persons sixty-five (65) years of age or over or for real property owned by a person with a disability whose income is limited by such disability, and used as the legal residence of such person, based on the income limits set forth below:

Maximum Income Limit	<b>Property Tax Exemption</b>
\$34,000.00	50%
\$34,000.00	45%
\$35,000.00-\$35,999.99	40%
\$36,000.00-\$36,999.99	35%
\$37,000.00-\$37,899.99	30%
\$37,900.00-\$38,799.99	25%
\$38,800.00-\$39,699.99	20%
\$39,700.00-\$40,599.99 \$40,600.00-\$41,499.99	15% 10%
\$40,000.00-\$41,499.99 \$41,500.00-\$42,399.99	5%

SECTION 4. Any person who qualifies for a property tax exemption as a person with a disability shall not be eligible for a property tax exemption as a person who is sixty-five (65) years of age or over.

SECTION 5. The maximum income limit set forth in Section 3 above shall be offset by medical and prescription drug expenses actually paid which are not reimbursed or paid for by insurance.

SECTION 6. This Local Law shall take effect immediately upon its filing in the Office of the Secretary of State.
