GUIDELINES FOR PUBLIC CONDUCT DURING TOWN BOARD MEETINGS

1. The Supervisor shall preside at the meetings of the Town Board. In the absence of the Supervisor, the Deputy Supervisor shall be the acting Supervisor. In the event both the Supervisor and the Deputy Supervisor are absent, the other members shall designate one of their members to act as temporary chairman. A majority of the Board shall constitute a quorum for the transaction of business, but a lesser number may adjourn.
2. Town residents who wish to speak shall fill out a card at the entrances of the meeting room listing their name, contact information, and the subject matter in which they would like to speak. These cards will be collected prior to the beginning of the Town Board meeting and given to the Town Supervisor or Deputy Supervisor in the absence of the Supervisor.
3. Speakers must be recognized by the presiding officer and then proceed to the lectern and state their name and address. They must limit their remarks on official town business to up to three minutes on a given topic and may not yield any remaining time to another speaker. They must address their remarks to the Board as a body and not to any member thereof and not to other members of the audience in the form of a debate.
4. Speakers should present their remarks in a courteous manner and may not make disparaging remarks or personal comments about public officials, town residents, or others. All speakers will observe the commonly accepted rules of courtesy, decorum, dignity, and good taste with no cursing, swearing, clapping, booing, finger pointing, bullying, whispering, or talking that disrupts the proceedings of the business of the Town Board.
5. Any speaker who disregards the directives of the presiding officer in enforcing the rules, disturbs the peace at a meeting, makes impertinent or slanderous remarks, or generally conducts themselves in an inappropriate manner shall be barred from further participation and will forfeit any balance of time remaining for their comments.
6. After a final warning, if a speaker willfully refuses to step down, the Town Supervisor shall contact the appropriate authorities to remove the speaker from the meeting room and to restore order.
7. The Town Supervisor, or in their absence the Deputy Supervisor, shall ensure compliance with these rules.

This policy will be amended by Majority vote of the Town Board.

Councilmember Boehlke: Dawn, so what’s the percentage of taxpayers in the Town of New Baltimore that looks like they’ll be eligible for this any idea?

Assessor DeRose: You’re probably gonna look at maybe about another 50 people that might qualify. You’re only raising it \$1,100 so it’s not gonna be a large amount.

Assessor DeRose: We have probably about 180 so far that are on it, so I would think no more than 50 more around.

Ellie Alfeld: The reason why I'm addressing the Town Board is first of all I know you had a meeting concerning the town roads of New Baltimore as it pertains to the electric lines that are coming in from Canada.

Supervisor Ruso: Oh, yes, that one.

Ellie Alfeld: That one. Could you tell me first of all how many Board Members were a party to that meeting on the roads I believe it was down by the kennels in thereabouts.

Supervisor Ruso: It was myself and one other.

Ellie Alfeld: Who's the one other?

Supervisor Ruso: Was it Chuck, weren't you there?

Councilmember Irving: Yes.

Ellie Alfeld: It's only two of you went? Okay.

Town Clerk Finke: More than that would be a meeting.

Supervisor Ruso: We don't put more than three...

Ellie Alfeld: I'm not questioning anything about it, I just wanted to know who was there that's all. The next thing I'd like to know is, refresh the memory of some of the Board members, if you remember back then we had that construction down by the trestle and it was pretty difficult for myself and the rest of the members on Independence Lane with the destruction of what that outfit did to our road and in fact it even took aerial photos of the damage in order to prove our case so that the road was repaired. I think you may remember some of that. What I would like to know is this outfit that is going to be running that line from I don't know Canada to New York City has already given you a map of where they will be running including the roads that that will agree in their contract with you to repair to your standards if there's any damage done. You signed a contract and, George, I believe you should have looked it over correct?

Town Attorney McHugh: Which contract, the CHPE? Yeah, I did.

Ellie Alfeld: Yes. Okay, what I'm asking you to keep in mind if they proceed off of their legally right-of-way property that is Central Hudson's right-of-way that they will be using and the railroad right-of-way from what I've been led to believe, if they go out of the bounds of that especially down where the trestle is in order to get out, are you prepared to represent the people on Independence Lane if we have to go through the damages that were inflicted like last time?

Supervisor Ruso: As it relates to Town roads, certainly.

Ellie Alfeld: Well, I put that road in. I paid with blood, sweat, and tears. The Town never paid anything for that road and they did none of the construction of that road so it perceives to be that it is a major concern to me what ends up with that road.

Supervisor Ruso: Sure. The road has for many years now, maintenance has been provided by the Town Highway Department for many years now and so any repairs and they plowed and they have certainly resurfaced that road so that would be continued by... that will be, yes they have.

Ellie Alfeld: When you say resurfaced you've got I betcha 100 places in this Town that have gotten blacktopped and everything like that. We've never been a party to that okay.

Supervisor Ruso: Thank you. Okay, the next comments I have are from Mr. Vadney. Proceed.

Harold Vadney: I'm certain we can agree that the privilege of voting is one of America's most taken for granted privileges so when elections start to get a little crooked and corrupt some of us wake up. Just some of us and we're a minority it seems. On December 6 right here in Town Hall a number of concerned citizens met to discuss and to address November 7th elections, voting machine failures, and other issues. A bipartisan group, NY Citizens Audit, sent two speakers to the meeting. Attendees even included residents of the Town of Bethlehem coming all the way out here from Delmar. But conspicuously absent were members of this Town Council specifically Ms. Downes, Ms. VanEtten, and Mr. Irving. To his credit Mr. Boehlke was present and participated in the discussions. Supervisor, Mr. Ruso, appeared late at the meeting but at least he attended. Deputy Supervisor Dellisanti was conspicuously absent. My question would be where were you people? This is a voting issue, an election issue, part of your government, part of the reason why you're sitting up there. Even more conspicuous and troubling was the absence of the recently-elected Town Councilpersons Janet Kash and Debra Sottolano, two outspoken Democrats who run the campaign political slogans of 'Politics Over People and listening to the people.' New Baltimore Democratic Committee Chairwoman Eileen Vosburgh was also conspicuously absent. One member of the New Baltimore Democratic Party, Mr. Rich Guthrie did attend, but when the Chair recognized him as the token Democrat, his response that he was there to see what was going on. Where were the Councilpersons-Elect and Democrat Party chairperson? Of course it would be too much to expect political hacks and appointees, Republican Brent Bogardus and Democrat Marie Metzler, to attend a bi-partisan meeting to address critical election issues after all they're only the Elections Commissioners. From the perspective of a voter and a resident I have to observe a total indifference of elected officials and voting discrepancies, malfunctioning voting machines, and the disgusting indifference of Board of Elections and the absence of these political hacks that was indicative of the source of the problem. A lot of talk during campaigns and nothing doing. I've heard such silly explanations as 'I didn't see the email.' Well, I think we can all agree that such stupid excuses belong to the likes of 'my dog ate the homework' and 'the check is in the mail.' They just don't work, they're not credible. I'll conclude my remarks with the observation that according to Supervisor Ruso the Town of New Baltimore is being billed \$11,000 for Election Day services from the County. I doubt if many of our Town residents are aware that we're paying that kind of money -- \$11,000 -- for the guaranteed Constitutional right to vote. Well, the ball is in your court members of this Town Council and the newly-elected Councilpersons to find out what's going on with the BOE, the Board of Elections, why we're paying for our privilege to vote, the apparent interference in government administration, abuse of office, defrauding the government, the para-conspiracy, and outright corruption not to mention violation of our civil rights. Aren't you elected officials the least concerned about these issues and haven't you taken an oath of office swearing to defend the Constitution? And I wonder what happened to that oath of office. I'll conclude with one last remark. I know that there's a resolution to approve recycling an antiquated Town Court printer/copier. Well, might I suggest that you also entertain a resolution for retiring and sunsetting these antiquated cassette recorders that we're using to record the proceedings here. How many times does the Town Clerk have to jump up and change tapes in the middle of a meeting? Why don't we just get rid of these things, sell them as antiques, and perhaps get a nice digital?

PESONS WITH DISABILITIES AND LIMITED INCOMES

BE IT ENACTED by the Town Board of the Town of New Baltimore, as follows:

SECTION 1. This Local Law is adopted pursuant to the authority of Real Property Tax §459© and §467. All definitions, terms and conditions of such statute shall apply to this Local Law and are incorporated herein.

SECTION 2. Local Law #1 of 2023 is HEREBY REPEALED.

SECTION 3. The Town Board of the Town of New Baltimore will follow the Greene County Senior Citizen Tax Exemption and hereby establishes the following sliding scale of property tax exemptions for real property owned by persons sixty-five (65) years of age or over and for real property owned by a person with a disability whose income is limited by such disability, and used as the legal residence of such person, based on the income limits set forth below:

SECTION 4. Any person who qualifies for a property tax exemption as a person with a disability shall not be eligible for a property tax exemption as a person who is sixty-five (65) years of age or over.

SECTION 5. The maximum income limit set forth in Section 3 above shall be offset by medical and prescription drug expenses actually paid which are not reimbursed or paid for by insurance.

SECTION 6. This Local Law shall take effect immediately upon its filing in the Office of the Secretary of State.

Supervisor Ruso: If I may ask is that with the amended amount for the...?

Town Clerk Finke: It was not, it was as we started.

Supervisor Ruso: There was an invoice pulled that comes to \$659.04 that needs further explanation so that's less that amount.

Supervisor Ruso: Thank you. So everyone's anticipated Mold Assessment. About two weeks ago it was noted by one of our staff that there was mold growing down below in our basement. I went down and took a look and certainly looks more substantial. As a result I called in a Certified Mold Inspector. I let the staff know to refrain from going into the basement and to call me if they needed anything such as a record or something beforehand. Also called the Sheriff's Department and told them as well. So we kept people out of the basement. The assessment has come through and I received it and it tells us what the problems are, it even gives a rough estimate of the cost. His assessment is \$300, but the abatement which we need to get a certified abatement company, he suggests it will be in the neighborhood of \$7,500. So the next step that I have, I actually reached out to one abatement company, I'd like to get a couple more and get some idea as to what they would have in mind and see if there a better pricing. But I don't have that as of yet. There are some suggested remedies to prevent recurrence certainly inclusive of fixing the gutters because that adds to the moisture around the building. I know we already have in-hand prior to this event a quote from a local company, Albright's, to install a dehumidifier. I'm going to have to call him back in. I just want to insure that the dehumidifier doesn't just address... I don't want the dehumidifier that's being proposed to just address a particular zone, but the entirety of the basement. So I will have to call them back to see exactly to insure that that dehumidifier fits in with what the mold assessment and abatement and prevention project is.

Councilmember Boehlke: That's really what's needed.

Supervisor Ruso: Yes, for the long haul. So, anyway, I wanted to make sure the Town Board is aware of this and I will be proceeding with getting quotes from others.

Councilmember Irving: Jeff, I noticed there was a mention about improving the grade around the building?

Supervisor Ruso: Yeah, I know there was some of that as well.

Councilmember Irving: But with the oncoming winter, changement of the ramp in the front, the handicapped ramps maybe, might be taken into consideration, future grading of that because if we don't do a job over again and the gutters are something that should be taken care of soon either way I would say.

Supervisor Ruso: Alright so that's what we will do.

Ellie Alfeld: Is this area where you detected the mold being used for storage of records or cardboard?

Supervisor Ruso: There are some papers in there, but the record room is free and clear.

Ellie Alfeld: But what I'm primarily asking about is cardboard. Is there any boxes of that nature?

Supervisor Ruso: Yup, there's some.

Ellie Alfeld: Because that contributes a great deal to mold.

Supervisor Ruso: The most severely affected room is the Code Enforcement Officer room which was installed about 20... It was before I came on the Board, 2010, 2011, okay and it's particularly low ceiling and they put zero ventilation in that room when they made the room. It used to be open and that's what the cause is. Now there are other areas where the mold has migrated to – some in the corridor, some in the I call it the holding room, it's part of the Sheriff's Department that has a two-way mirror, handcuff things on the wall, police station.

Councilmember Irving: The other thing, Jeff, is that the duct work and the propane hot air heating system is antiquated. With the new air source heat pumps they provide, dehumidification without having to go to a further step, they have built-in dehumidification and would probably be something that might get considered.

Supervisor Ruso: This room has been, the door has been closed and seldom used so clearly that room which is the source and focal point of the problem needs to be opened up I'm thinking as well as a dehumidifier fixing that.

Councilmember Irving: There is a dehumidifier downstairs. Was that being run?

Supervisor Ruso: The dehumidifier in the records room, Town Clerk's record room, is working perfectly fine and that area is perfectly fine.

Harold Vadney: One thing to take into consideration is the fact that if you have vital mold growing now or mildew, the difference between the two (unable to understand) and you have vent work, then you have the problem of spores and you're going to have to deal with that.

Supervisor Ruso: It's all there.

Harold Vadney: It's in there? Spores are rather dangerous to humans and documents.

Supervisor Ruso: As are the mice. Well, anyway, I don't have a resolution for today, but I want to make sure people were alert to this. I'm going to proceed accordingly based upon the quotes I get, but I can't wait much longer. I want to get it going okay and some of the issues may not be well-resolved until the spring such as I don't know if, weather could hit us any day

Supervisor Ruso: Well, we need plow trucks and we don't have our new plow truck until at least next year. They haven't started building it yet.

Supervisor Ruso: Yeah, up to \$10,000.

Councilmember Boehlke: We're always supposed to get at least two bids on a contract. So I'm just questioning it, that's all.

Supervisor Ruso: Correct. We have to have formal bids when it's in excess of \$10,000 which gives me another reason why I'm going to say 'not to exceed.'

Councilmember Downes: And was Mr. VanWormer requested to be here tonight?

Supervisor Ruso: The problem is I have two more plow trucks that are in different garages. I have three different garages right now. We have three different garages, three different plow trucks, and I have this one invoice. I don't what to say.

Councilmember Boehlke: Well, at the rate we're going we ought to have probably about half a dozen contractors in reserve right?

Ellie Alfeld: Did we ever get bids on the people plowing for the Town?

Supervisor Ruso: No, we didn't. Well, they hired people and that was only a contingency in the event we didn't have staff.

Ellie Alfeld: Well, I knew you hired, I didn't know if you honored that bid that's all.

Councilmember Downes: And have we been told how many people passed their CDLs?

Supervisor Ruso: Last meeting he said sometime soon. Well, he did say, he said he expected soon.

Ellie Alfeld: Christmas is sometime soon, too.

Supervisor Ruso: Stop it, don't be mean, don't be mean.

Harold Vadney: This is a little bit perplexing really because back in September (unable to understand) sealed bid procedures etc. for the new truck that your purchased for \$49,000 and he only got one bid. I don't understand why we don't have a vendor list or a supplier list. I don't understand why Alan is not getting a response from these people. Maybe Alan needs some clerical support. Maybe Alan needs some training in requesting bids. This is very unusual.

So let's save it for a time when people are here, I don't want to throw things in absentia as I said.
